ANNUAL GENERAL MEETING OF SHAREHOLDERS

You are receiving this Notification because **Martinrea International Inc.** (the “**Company**” or “**Martinrea**”) has decided to use the notice and access model for the delivery of meeting materials to its shareholders in respect of its Annual General Meeting of Shareholders to be held on **Tuesday, June 9, 2026** (the “**Meeting**”).
