PRIVACY POLICY

Martinrea is committed to protecting the security and privacy of your personal information (as defined under the *Personal Information Protection and Electronic Documents Act*). We hope the policy outlined below will help you understand our collection, use and disclosure of personal information in connection with this web site.

Personal Information

By submitting personal information (e.g. your name, residential address, telephone number or e-mail address) through our web site, you consent to our collection, use and disclosure of your personal information for the purposes for which it was submitted. Your personal information may be shared subsidiaries of Martinrea if necessary. You may withdraw your consent at a later time by contacting us. Purpose of Use

Cookies

A cookie is a small text file containing a unique identification number that identifies your browser, but not you, to our computers each time you visit one of our web sites that uses cookies. content. If you wish, you can reset your browser either to notify you when you have received a cookie or refuse to accept cookies. However, if you refuse to accept cookies, you may not be able to use some of the features available on our web site.
